

## 2017 Calisthenics Ambassador Program Sponsored by TryBooking

### Criteria and Process

The Calisthenics Ambassador Program Sponsored by TryBooking aims to identify an individual within the calisthenics community who exemplify how calisthenics has impacted their lives inside and outside of their classes, rehearsals and performances, and how it has helped them succeed in life.

These individuals will represent Victorian Calisthenics and highlight the benefits including confidence, discipline, strength, teamwork and performance.

### Section 1: Criteria and Nominations

One individual will be offered a 12 month Ambassadorship with CVI (June 2017 to June 2018) and will be asked to share 3 'moments of their time' throughout 2017-18 to help promote calisthenics. The 'moment' may include, but are not limited to:

- Official announcement and presentation at the 2017 Celebrating Calisthenics event
- Media activity
- CVI State Championship appearances
- State Team Concert appearances
- CVI Partnership meetings

All nominees must have at least 3 years calisthenic experience as a participant or coach and the success of each application will be measured on the contents of the application.

### The selection criteria is

1. Experience and outcomes of candidate as a participant or coach
2. Experience and outcomes of candidate as a volunteer or committee member
2. Examples of performance and technical training
3. Evidence of leadership within Victorian Calisthenics
4. Evidence of confidence, discipline, strength and teamwork outside of Calisthenics, but attributable to calisthenics.

### Process for nomination

Any member of Calisthenics Victoria or affiliated organisations is entitled to 1 nomination for the CVI Ambassadorship program.

For the purpose of these awards, an affiliated organisation is defined as:

- CVI Committee members
- Victorian Calisthenic Coaches Association (VCCA)
- Australian Society of Calisthenic Adjudicators (ASCA) Victorian Branch
- Australian Calisthenic Federation (ACF)

#### Condition of Nomination:

- All nominations must be on the official nomination form
- All nomination information and material submitted remains the property of Calisthenics Victoria
- It is essential that nomination forms are completed in full, including the name and contact details of both the nominee and the nominator.

The nominator must sign the completed nomination form and have it seconded prior to lodging the application. Failure to do so will result in the nomination being deemed ineligible.

### **Section 3: Key dates, Selection Procedure and Terms of Conditions**

#### Key Dates

Applications Open: Tuesday 28 February 2017

Applications Close: Friday 31 March 2017 5pm

#### Selection Procedure

A panel comprising representatives from CVI, its affiliated organisation and an independent stakeholder will select the 2017 TryBooking Ambassador.

The Ambassadors will be announced at the 2017 Celebrating Calisthenics event on 18 June 2017 at Myer Mural Hall, Bourke Street, Melbourne.

The decision of the 2017 Trybooking Ambassadorship selection panel is final and no correspondence will be entered into. An unsuccessful nomination does not preclude the nomination being submitted in successive years.

#### Terms and conditions

- Nominee and Nominator cannot be the same person
- All information and photos provided may be used for promotional purposes in the lead up to, during and after the event in the promotion of the event or CVI as an organisation.
